Paul H. Franke & Helen B. Franke, grantor
 of Salt Lake City, County of Salt Lake, State of Utah,
 hereby grants, bargains and sells to the STATE ROAD COMMISSION OF UTAH, Grantee, for
 the sum of Two hundred & sixty (\$260.00) DOLLARS,
 the following described strip or parcel of land, as a perpetual right of way for highway purposes
 across the grantor's land in Salt Lake, County, State of Utah, as follows:

Right of way for highway known as P. A. Project No. 229 across the grantor's
 land in Lot 108, Glendale Park, Plat "A", in the SW 1/4 SW 1/4 of Section 10, T. 1 S.,
 R. 1 E., S. L. M. Said right of way is contained within a parcel of land 50 ft. wide,
 50 ft. on the east side of the center line of survey of said project. Said center
 line is described as follows:

Beginning at the intersection of the north boundary line produced of said
 grantor's land and said center line of survey at Engineer's Station 100+67, which
 point is on the city monument line of Redwood Road and approximately 450.4 ft.
 northerly from the south $\frac{1}{2}$ corner of said Section 10; thence S. 06°03'08" E., 425.4
 ft. along said city monument line to the intersection of said center line of survey
 at Engineer's Station 104+92.4 and the south boundary line produced of said grantor's
 land, which point is approximately 25 ft. northerly from said south $\frac{1}{2}$ corner
 of Section 10, as shown on the official map of said project on file in the office
 of the State Road Commission of Utah. Above described parcel of land contains 0.49
 acre, of which 0.36 acre is now occupied by the existing highway and the property
 of Salt Lake City, Balance 0.13 acre.

In executing this deed, the grantor hereby grants to the State Road Commission of Utah permission to relocate and reconstruct within the grantor's land and outside the limits of above described right of way, all irrigation ditches existing
 within said limits of above described right of way, and to extend onto said grantor's land and outside the limits of above described right of way, all cut and fill
 slopes made necessary by the grading for sidewalks on said right of way.
