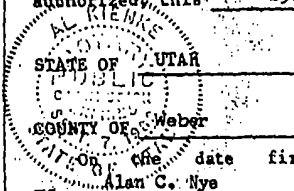
a perpetual easement, upon part of an entire tract of property, in the SW1/4 of Section 1, T. 5 N., R. 2 W., S.L.B. & M., in Weber County, Utah, for the purpose of constructing and maintaining thereon a traffic signal pole and appurtenant parts thereof incident to the construction of a traffic safety improvement known as Project No. 9792.

The boundaries of said part of an entire tract are described as follows:

Beginning at the intersection of the north right of way line of 4000 South Street and the east right of way line of 1900 West Street (State Route No. 126) known as FAP-214, which point is 34.28 feet N. 0°33' E. and 50 feet N. 89°27' E. from the Southwest corner of said Section 1; thence N. 89°05' E. 10 feet along said north right of way line; thence N. 45°24' W. 14.01 feet to said east right of way line; thence S. 0°07' W. 10 feet along said east right of way line to the point of beginning.

The above described part of an entire tract contains 0.001 acre, more or less.
