 I, the undersigned hereby grant and convey unto said Company, its successors and assigns, to and their respective officers, agents, licensees and agents, a right of way and easement to construct, operate, maintain, repair and remove all communication systems, equipment, devices and facilities, and services, as the grantee may from time to time require, consisting of underground cables, wires, conductors, poles and supporting towers, and surface poles, and surface markings, repeaters and markers, and other appurtenances, upon, over and under a strip of land, hereinafter described, which the undersigned owns or in which the undersigned have any interest in The North Half of the Section Line (Line) of Section 32, Township 1 North, Range 2 East, - - - - -  
 said strip of land being Twenty (20) feet in width. - - - - -

of S.L.B. M., County of Salt Lake, and State of Utah,  
 together with the following rights: Of ingress and egress over and across the lands of the undersigned to and from said strip for the purpose of exercising the rights herein granted; to lay, run, support and maintain said communication system; to clear and keep cleared all trees, roots, brush and other obstructions from the surfaces and subsurfaces of said strip; to install gates in any fence crossing said strip; and to permit in said strip the cables, wire, circuits and appurtenances of any other company. The northerly boundary of said ~~strip~~ strip shall be a line parallel to and three feet northerly of the first cable laid, which cable shall have the location indicated upon surface markers set at intervals on the land of the undersigned or on lands adjacent thereto. The undersigned for ~~the~~ <sup>themselves</sup>, heirs, executors, administrators, successors and assigns, hereby covenant that no structure shall be erected or permitted on said strip. The grantees agree to pay for damage to fences and growing crops arising from the construction and maintenance of the aforesaid system.

There is reserved to the grantors the right to use the land hereinabove described for agricultural purposes or other purposes to such extent as shall not be inconsistent with the beneficial enjoyment by the grantees of the rights herein granted.
