THIS FOURTEENTH AMENDMENT TO THE BY-LAWS OF THE HOMEOWNERS ASSOCIATION FOR THE COLONY AT WHITE PINE CANYON is made and executed on the date set forth below and shall be effective upon recording in the Summit County Recorder's Office.

### Amendment One - Section 2.1

Section 2.1 of the By-Laws is hereby amended to read as follows;

Joll Color "2.1 Number of Board of Trustees. The affairs of the Association shall be conducted by a Board of Trustees composed of seven to individuals. In the event there are fewer candidates than vacancies for the Board of Trustees, the Board of Trustees may reduce the Board of Trustees size to five (5) individuals until the next annual meeting of the RICILGOPY Members."

#### Amendment Two - Section 2.3

Amendment Three - Section 2.7

Section 2.7 of the By-Laws is hereby amended to read as follows

**\*\*2.7** Quorum Election of Officers and Voting. A majority of the members of the Board of Trustees shall constitute a quorum and If a quorum is present, the decision of a majority of those present shall be the act of the Board of Trustees. The officers shall be elected at a meeting of the Board of Trustees to be called following the annual meeting of the Association. If an officer ceases to serve due to resignation, death or removal, the UMORICICI Board of Trustees may elect a replacement officer as soon after such event as is reasonably  $_{

Amendment Four - Section 3.1

Section 3.1 of the By Daws is hereby amended to read as follows:

UMO

"3.1 (Quorum and Voting. The presence in person or by proxy at any meeting of the Members of the Association, duly called and noticed, representing a majority of the total of all votes vested in Members, shall constitute a quorum for the transaction of business. If however, such quorum shall not be present or represented at any meeting, the

Board of Trustees shall have power to adjourn the meeting and reschedule for a time not earlier than twenty-four (24) hours, nor later than fifteen (15) down after the 10110000 the original meeting. No notice of such rescheduled meeting shall be required except an oral announcement at the meeting to be rescheduled. The presence of Members and holders of proxies entitled to cast more than thirty-five percent (35%) of the total of all votes vested in Members shall constitute a quorum for the transaction of business at the rescheduled meeting. Unless otherwise provided in the Declaration, Bylaws, or Articles, any action may be taken at any meeting of the Members of the Association where a quorum is present, upon the affirmative vote of a majority of the votes of the Members present?

## Amendment Five - Section 3.2

Section 3.2 of the By-Laws is hereby amended to read as follows:

4325 Annual Meeting. There shall be an annual meeting of the Members of the Association on the 29th of December at the main entry gate to The Colony, or at such other reasonable place (any location within Summit County shall be deemed reasonable) or time (not more than thirty days before or after such date) as may be designated by written notice from the Board of Trustees. Written notice of the annual meeting shall be send to the Members not less than difteen (15) days prior to the date fixed for the annual meeting and may be sent by personal delivery; by first class United States Mail, postage prepaid; or by email. Delivery by United States Mail is deemed to have been delivered three (3) days after a copy has been posted in the United States mail. At or prior to such meeting, the Board of Trustees shall furnish to the Members a proposed budget for the next fiscal year that shall itemize the estimated Common Expenses and Assessments for the fiscal year with the estimated allocation thereof to each Member, and a statement of the Common Expenses and Assessments for the fiscal year just concluded with an itemization of receipts and disbursements for that year and the allocation to each Member of those amounts."


