## A RESOLUTION APPROVING THE ANNEXATION OF THE TOKUO YOSHIMURA AND UTAH POWER & LIGHT PROPERTIES

WHEREAS, the Roy City Council has duly considered the petition for annexation executed by Tokuo Yoshimura and Utah Power & Light properties and after having held the necessary public hearings thereon and it appearing that it is in the best interest of Roy City and the petitioning property owners that this annexation be approved.

NOW, THEREFORE, Be it resolved by the Roy City Council of Roy City, Utah, that the following-described property be and hereby is annexed and is to be included within the boundaries of Roy City:

BEING A PART OF THE SOUTHEAST ONE-QUARTER OF SECTION 16, T5N, R2W, S.L.B. & M. AND DESCRIBED AS FOLLOWS:

BEGINNING AT THE SOUTHEAST CORNER OF SAID SECTION 16, (AS MONUMENTED) AND RUNNING: THENCE S89°58'17"W, ALONG THE SOUTH LINE OF THE SOUTHEAST ONE-QUARTER OF SAID SECTION 16, (AS MONUMENTED), 183.00 FEET; THENCE N0°01'25"E, 183.00 FEET; THENCE S89°58'17" W, 87.00 FEET; THENCE N0°01'25"E, 562.89 FEET TO THE CENTERLINE OF 5500 SOUTH STREET; THENCE S89°28'43"E, ALONG THE CENTERLINE OF 5500 SOUTH STREET, 270.00 FEET TO THE EAST LINE OF THE SOUTHEAST ONE-QUARTER OF SAID SECTION 16, (AS MONUMENTED), ALSO BEING THE CENTERLINE OF 3500 WEST STREET; THENCE S0°01'25"W, ALONG SAID EAST LINE, ALSO BEING ALONG THE CENTERLINE OF 3500 WEST STREET, 743.30 FEET TO THE POINT OF BEGINNING. CONTAINS 4.25 ACRES, MORE OR LESS.
