AMENDMENT TO DECLARATION OF COVENANTS, CONDITIONS AND RESTRICTIONS OF TWIN BRIDGES P.U.D.

THIS AMENDMENT TO THE DECLARATION OF COVENANTS, CONDITIONS AND RESTRICTIONS OF TWIN BRIDGES P.U.D. ("Amendment") is made this 2 day of September, 2005, by Twin Bridges P.U.D. Owners Association, Inc., a Utah non profit corporation (the "Association"), approved by the owners who currently hold ownership of more than 67% of the Lots.

RECITALS

This Amendment is made with reference to the following facts and objectives:

- A. On or about April 9, 2004, DBC Enterprises, LLC, a Utah limited liability company, as Declarant, recorded or caused to be recorded that certain Declaration of Covenants, Conditions and Restrictions of Twin Bridges P.U.D., recorded in the office of the Salt Lake County Recorder as Entry No. 9029022, in Book 8970, at page 8707 (the "CC&Rs").
- B. Section III.31 of the CC&Rs provides that any of the covenants and restrictions of the CC&Rs, may be amended by a recorded instrument, after voting of the members of the Association entitled to cast not less than sixty-seven percent (67%) of the votes of the membership, including the approval of the Declarant.
- C. The members of the Association representing more than sixty-seven percent (67%) of the votes of the membership of the Association now desire to amend certain provisions of the CC&Rs.

NOW THEREFORE, in consideration of the premises, the Association hereby makes this Amendment:

AMENDMENT TO DECLARATION OF COVENANTS, CONDITIONS AND RESTRICTIONS - 1

1. Amendment to Section III.5(e)(20). SECTION 5(e)(20) of Section III of the CC&Rs is hereby amended by deleting the first paragraph and replacing it with the following:

"No animals, livestock, or poultry of any kind shall be raised, bred, or kept at the Project, except that no more than 2 dogs that weigh less than thirty (30) pounds or measure less than thirty (30) inches in height measured at the back hips, and/or no more than 2 cats may be kept in or on a Lot, subject to any additional rules and regulations adopted by the Association through its Management Committee. Notwithstanding any of the foregoing, no dog of any breed that is commonly known as an aggressive breed shall be allowed---including, but not limited to, pits bulls and rottweilers. Under no circumstances shall any pets be kept, bred, or maintained for any commercial purpose."

2. Except as expressly set forth in this Amendment, all other terms and conditions of the CC&Rs shall remain in full force and effect. In the event of any inconsistency between this Amendment and the CC&Rs, this Amendment shall control.
