AMENDMENT TO THE

AMENDED DECLARATION

# OF COVENANTS, CONDITIONS, AND RESTRICTIONS FOR THE THREE FOUNTAINS CONDOMINIUM PHASE ONE THROUGH SIX

This Amendment is made and executed this 6 day of Oct , 2005, by the Board of Trustees of Three Fountains Condominiums (the "Association").

#### Recitals

A. The Amended Declaration of Covenants, Conditions, and Restrictions for the Three Fountains Condominium Phases One through Six, was recorded in the Salt Lake County Recorder's office beginning at Book 7920, Page 1449, as entry No. 6903211 (the "Declaration").

B. As evidenced by this instrument, the Board of Trustees has obtained the approval of the Owners to amend the Declaration as provided for in Paragraph 33 of the Declaration.

NOW, THEREFORE, pursuant to the foregoing, the Board of Trustees hereby makes and executes this amendment to the Declaration and any prior amendments to the Declaration, which shall be effective as of its recording date.

- 1. <u>Amendment #1 (Eliminating need for acknowledgments for amendment and clarifying signature requirement)</u>. Paragraph 33 of the Declaration is amended by deleting the current section in its entirety, substituting the following:
  - 33. <u>Amendment</u>. Except as otherwise provided herein, the provisions of this Amendment may be amended by an instrument in writing signed by the Record Owners holding sixty-seven percent (67%) of the total vote of the Members. The amendment shall be effective upon recordation in the office of the Recorder of Salt Lake County, State of Utah. If a Unit is owned by more than one Record Owner, the signature of any one Record Owner shall be sufficient to constitute approval for that Unit under this paragraph.
- 2. <u>Amendment #2 (Eliminating need for acknowledgments for certificate)</u>. Paragraph 12 of the Declaration is amended by deleting "and acknowledged" from the paragraph after subparagraph (b).
- 3. <u>Conflicts.</u> All remaining provisions of the Declaration and any prior amendments not

specifically amended in this Amendment shall remain in full force and effect. In the case of any conflict between the provisions of this document and the provisions of the Declaration or any prior amendments, the provisions of this document shall in all respects govern and control.

4. <u>Incorporation and Supplementation of Declaration</u>. This document is supplemental to the Declaration, which by reference is made a part hereof, and all the terms, definitions, covenants, conditions, restrictions, and provisions thereof, unless specifically modified herein, are to apply to this document and are made a part hereof as though they were expressly rewritten, incorporated, and included herein.
