Toben S. Leeflag, Grantor, of Riverton,
 County of Salt Lake, State of Utah, hereby GRANTS AND CONVEYS
 to the UTAH DEPARTMENT OF TRANSPORTATION, at 4501 South 2700 West, Salt Lake
 City, Utah 84119, Grantee, for the sum of Ten, Dollars,

a perpetual easement, upon part of an entire tract of property, in the NW1/4SE1/4 of
 Section 27, T.3S., R.1W., S.L.B.&M., in Salt Lake County, Utah, for the purpose of
 constructing and maintaining thereon public utilities and appurtenant parts thereof
 including, but not limited to ATMS fiber optic conduit, electrical service and transmission
 lines, culinary and irrigation water facilities; and highway appurtenances including, but not
 limited to slopes, street and signal lighting facilities, directional and traffic information signs.

The boundaries of said part of an entire tract of land are described as follows:

Beginning in the south boundary line of said entire tract at a point 1315.94 feet
 (79.54 rods by record) South along the quarter section line and 59.44 feet East from the
 Northwest Corner of the Southeast Quarter of said Section 27, said point is also
 approximately 59.50 feet perpendicularly distant easterly from the centerline of the existing
 highway State Route 68 opposite engineer station 74+38.74, and running thence West
 6.50 feet along said south boundary line to a point 53.00 feet perpendicularly distant
 easterly from said centerline, said point is also the beginning of a non-tangent 8053.00 foot
 radius curve to the left; thence northerly along the arc of said curve 36.69 feet through a
 delta of 00°15'40" (Note: Chord to said curve bears N.00°07'36"E. for a distance of
 36.69 feet) to a point 53.00 feet perpendicularly distant easterly from said centerline
 opposite engineer station 74+75.2±; thence N.00°00'14"W. 47.47 feet along a line parallel
 with and 53.00 feet perpendicularly distant easterly from said centerline to the northerly
 boundary line of said entire tract; thence N.89°52'25"E. (East by record) 6.50 feet along
 said northerly boundary line; thence S.00°00'14"E. 47.48 feet along a line parallel with said
 centerline; thence S.00°07'36"W. 36.69 feet to the point of beginning. The above described
 part of an entire tract of land contains 547 square feet or 0.013 acre in area, more or less.

(Note: Rotate all bearings in the above description $00^{\circ}22'06''$ clockwise to obtain highway bearings.)

It is agreed hereby, that the Owners, by consent of the Utah Department of Transportation, shall have the right to lessen but not to increase the vertical distance or grade of said cut and/or fill slopes.

After said public utilities and appurtenant parts thereof are constructed on the above described part of an entire tract at the expense of the Utah Department of Transportation, said Utah Department of Transportation is thereafter relieved of any further claim or demand for costs, damages or maintenance charges which may accrue against said public utilities and appurtenant parts thereof.


