## CORRECTED DEED OF RIGHT-OF-WAY

THIS CORRECTED DEED OF RIGHT-OF-WAY is made and entered into this  
25<sup>th</sup> day of JUNE, 2007, by and between M. VAL DALTON and  
ALETA L. DALTON, Grantors, and SAN JUAN COUNTY, a Utah Body Politic, with its  
principal place of business located at, Post Office Box 9, 117 S. Main Street, Monticello, San  
Juan County, Utah 84535, Grantee.

WITNESSETH: That Grantors, for and in consideration of the sum of Ten Dollars  
(\$10.00) and other good and valuable consideration, the receipt and sufficiency of which is hereby  
acknowledged, does hereby grant unto the Grantee, its successors and assigns, forever, a right-of-  
way in fee for road purposes over and across a strip of land 33 feet on each side of the following  
described centerline all within Section 7 T36S R25E SLB&M, the side lines of said strip to be  
shortened or lengthened to terminate property lines, the East line of Section 7, and the West line  
of E1/2 E1/2 of Section 7, San Juan County, State of Utah, the said centerline being more  
particularly described as follows:

Commencing at the NE corner of Section 7, T36S R25E SLB&M, thence South along the  
East line of Section 7, a distance of 1963.39 feet to the true point of beginning; thence  
N44°34'42" W 376.80 feet, thence N72°24'25" W 291.53 feet; thence S61°04'58" W 437.64  
feet; thence S11°34'01" W 379.40 feet; thence S06°36'31" W 802.39 feet; thence  
S22°41'39" W approx. 388.84 feet to the intersection of the West line of the E1/2E1/2 of  
Section 7. Basis of bearing is the North line of Section 7, more particularly being N89°44'  
E between the NW corner, a found brass cap, and the NE corner a found brass cap, of  
Section 7, T36S R25E, SLB&M.

The Grantors, for themselves and their successors and assigns, does covenant with the  
said Grantee and its successors and assigns, that they are seized in fee of the above-described  
premises, that they have good right to sell and convey such easement and rights as aforesaid.
