## DEED OF GRANT OF EASEMENT

For and in consideration of the sum of One Hundred and Twenty-Five Dollars (\$125.00), to be paid to the Grantor by the Grantee upon acceptance of this instrument, the Clinton Corporation of the Church of Jesus Christ of Latter-day Saints, a corporation sole consisting of Myron B. Child, Bishop of the Clinton Ward of the Church of Jesus Chirst of Latter-day Saints, Grantor, hereby grants and conveys to the United States of America, Grantee, its assigns and successors, a perpetual easement to construct, operate, maintain, repair and replace pipe lines and appurtenances for the conveyance of sewage from or under a portion of the land owned by the Grantor, situated in the County of Davis, State of Utah, more particularly described as follows:

A strip of land twenty (20) feet wide, lying ten (10) feet (measured at right angles) on each side of a center line which is described as follows:
