 recorded in the office of the Salt Lake County Recorder.

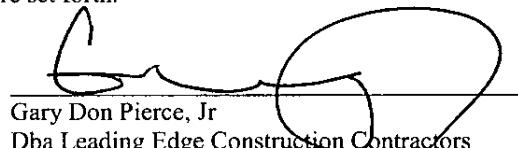

 expended or advanced by Beneficiary to protect the security hereof.**

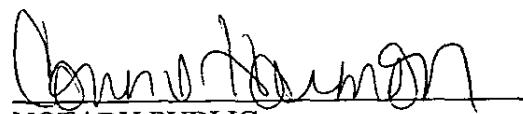
Trustor agrees to pay all taxes and assessments on the above property, to pay all charges and
