The precise location of said pole and equipment shall be as agreed upon between the parties hereto at the time of the erection thereof.

Together with all rights of ingress and egress necessary or convenient for the full and complete use, occupation and enjoyment of the easement hereby granted, and all rights and privileges incident thereto, including the right to trim trees and cut out brush and overhanging branches as required to make proper and efficient construction.
