Assignor does hereby warrant title to the leases described herein to the extent and only to the extent of the warranty received by Assignor when Assignor acquired its interests in said leases.

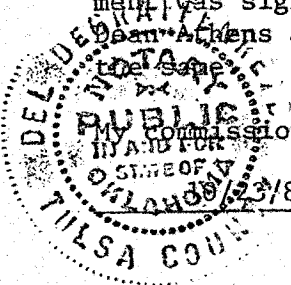
