TO ALL TO WHOM THESE PRESENTS SHALL COME, GREETING:

WHEREAS, LOREN WHITEHEAD Salina, of the County of Sevier State of Utah here-
tofore purchased from the State of Utah, the lands hereinafter described, pursuant
to the laws of said State in such case made and provided,

AND WHEREAS, the said LOREN WHITEHEAD has paid for said lands, pursuant to the
conditions of said sale, and the laws of the State duly enacted in relation thereto,
the sum of Three Hundred Fifty and No/100 (\$350.00) Dollars, and all legal interest
thereon accrued, as fully appears by the certificate of the proper officer, now on
file in the office of the Secretary of State of the State of Utah;

NOW THEREFORE, I HERBERT B. MAW, Governor, in consideration of the premises, and by virtue of the power and
authority vested in me by the laws of the State of Utah, in such case made and provided, do issue this PATENT,
in the name and by the authority of the State of Utah, hereby granting and confirming unto the said LOREN WHITE-
HEAD and to his heirs and assigns forever, the following piece or parcel of land, situate in the County of Sevier
State aforesaid, to-wit:

West Half ($W\frac{1}{2}$) of the Southeast Quarter ($SE\frac{1}{4}$); South Half ($S\frac{1}{2}$) of the Northeast Quarter ($NE\frac{1}{4}$) of the South-
east Quarter ($SE\frac{1}{4}$); Southeast Quarter ($SE\frac{1}{4}$) of the Southeast Quarter ($SE\frac{1}{4}$) of Section Thirty-six (36), Township
Twenty-one (21) South, Range One (1) West, Salt Lake Meridian.

(Reserving to the State of Utah, all coal and other minerals, in the above lands, and to it, or persons authorized by it, the right to prospect for, mine and remove coal and other minerals from the same, upon compliance with the conditions and subject to the limitations of Title 86-Chapter 1, Revised Statutes of Utah 1933 and amendments thereto.)

containing One Hundred Forty & No/100 (140.00) acres according to the said certificate.

TO HAVE AND TO HOLD the above described and granted premises unto the said LOREN WHITEHEAD and to his heirs and assigns forever, subject to any easement or right of way of the public, to use all such highways as may have been established according to law, over the same or any part thereof, and subject also to all rights of way for ditches, tunnels, and telephone and transmission lines that may have been constructed by authority of the United States.

IN TESTIMONY WHEREOF, I have hereunto set my hand and caused the great seal of the State of Utah to be hereunto affixed.

Done at Salt Lake City, this nineteenth day of October in the year of our Lord, one thousand nine hundred and Forty-four, and of the independence of the United States of America the one hundred and Sixty-eighth, and in the Forty-ninth year of the State of Utah.
