AMENDMENT TO CONDOMINIUM DECLARATION FOR WINDRIFT CONDOMINIUMS

This Amendment to Condominium Declaration for Windrift Condominiums is made and executed by the Windrift Condominiums Owner's Association, Inc., a Utah non-profit corporation, of 2076 Mahre Dr., Park City, UT 84098 (the "Association").

RECITALS

- A. The Condominium Declaration for Windrift Condominiums was recorded on October 12, 1979 as Entry No. 160192 in Book M143 at Pages 331-368 of the official records of the County Recorder of Summit County, Utah (the "Declaration").
- B. The related plat map has also been recorded in the office of the Summit County Recorder (the "Final Plat").
- C. This document affects the real property located in Summit County, Utah, described with particularity on Exhibit "A," attached hereto and incorporated herein by this reference.
- D. The Association desires to make the project and all buildings "No Smoking" because second hand tobacco smoke is a carcinogen.
 - E. All of the voting requirements have been satisfied.

AMENDMENT

NOW, THEREFORE, for the reasons recited above and for the benefit of the Windrift Condominium and the Unit Owners thereof, the Association hereby executes this Amendment to Condominium Declaration for Windrift Condominium.

- 1. **Amendment**. Article VII, Section (b) of the Declaration is hereby amended to add the following new use restriction and subsection:
 - (9) **No Smoking**. Windrift Condominium is a No-Smoking Project. Smoking at Windrift Condominium is not allowed in any Units, the Limited

Common Area, Common Area and Facilities, or within twenty-five feet (25') of any building, and shall be considered a nuisance per se.

- **Incorporation by Reference.** It is expressly agreed by the undersigned that this amendment is supplemental to the Declaration, which is by reference made a part hereof, and all the terms, conditions, and provisions thereof, unless specifically modified herein, are to apply to this contract and are made a part of this contract as though they were expressly rewritten, incorporated, and included herein.
- **Conflict.** In the event of any conflict between the provisions of this Amendment and any other provision in the Declaration, the former shall in any and all respects govern and control.
- Effective Date. The effective date of this Amendment is the date it is recorded in the office of the County Recorder of Summit County, Utah.
