Whereas by pursuance of the Act of Congress, approved July 2, 1863, entitled "An Act donating Public Lands to the several States and Territories which may provide Colleges for the benefit of Agriculture and the Mechanic Arts, there has been deposited in the General Land Office, Scrip No. 1874, for one quarter section of lands, in favor of the State of Tennessee, duly assigned by the proper authority of the said State to Samuel Fowler, and by him to Ebenezer G. Richardson with evidence that the same has been located upon the South West Quarter of Section Four in Township Six North, of Range Two West, in the District of Lands subject to sale at Salt Lake City, Utah Territory, containing one hundred and sixty acres according to the Official Plat of the survey of the said Lands, returned to the General Land Office by the Surveyor General:

Now know Ye, That there is therefore, granted by the United States unto the said Ebenezer G. Richardson as assignee (as aforesaid, and to his heirs the tract of Land above described: To Have and to Hold, With said tract of Land, with the appurtenances thereof, unto the said Ebenezer G. Richardson as assignee as aforesaid and to his heirs and assigns forever, subject to any vested and accrued water rights for mining, agricultural, manufacturing, or other purposes, and rights to ditches and reservoirs used in connection with such water rights, as may be recognized and acknowledged by the local customs, laws, and decisions of courts, and also subject to the right of the proprietor of a vein or lode to extract and remove ore therefrom, should the same be found to penetrate or intersect the premises hereby granted, as provided by law.
