Witnesseth that the said party of the first part, for and in consideration of the sum of Five (500) Dollars, lawful money of the United States of America, to him in hand paid by the said party of the second part, the receipt whereof is hereby acknowledged, has granted, bargained, sold, aliened, remised, released, conveyed and confirmed, and by these presents does grant, bargain, sell, alien, remise, release, convey and confirm, unto the said party of the second part and to its heirs and assigns forever, all of the following described strip of land one hundred feet wide (100) fifty feet wide from the centre of the U. S. R. R. track on each side through the north half of the north west quarter of section ^{thirty} three and through the South west corner of the S. W. 1/4 of the South west quarter of Section twenty eight all in Township Three South of Range one East Salt Lake meridian, Beginning in the centre of the U. S. R.
