POLE LINE EASEMENT

Alma Gibby and Eva U. Gibby his wife, Grantors of Weber County, Utah hereby convey and warrant to UTAH POWER & LIGHT COMPANY, a corporation, its successors in interest and assigns, Grantee, for the sum of One (\$1.00) Dollar and other valuable consideration, a perpetual easement and right of way for the erection and continued maintenance, repair, alterations, and replacement of the electric transmission, distribution and telephone circuits of the Grantee, and 1 pole, no guys with the necessary stubs, cross-arms and other attachments thereon, or affixed thereto, for the support of said circuits, to be erected and maintained upon and across the premises of the Grantors in Weber County, Utah, along a line described as follows:

Beg. on the south boundry line of grantor's land at a point 1726 ft. east and N. 1° 26' E. 1368 ft., more or less, from the SW corner Sec. 30, T. 6 N. R. 1 W., S. L. B. & M., th running N. 1° 26' E. 65 ft., more or less, to north bndy line of said land.

Also beg. on the south bndy line of grantor's land at a point 1726 ft. east and N. 1° 26' E 528 ft., more or less, from the SW corner Sec. 30, T. 6 N., R. 1 W., S. L. B. & M., th. running N. 1° 26' E 114 ft., more or less, to north bndy line of said land.

Together with all rights of ingress and egress necessary or convenient for the full and complete use, occupation and enjoyment of the easement hereby granted, and all rights and privileges incident thereto, including the right to cut and remove timber, trees, brush, overhanging branches and other obstructions which may injure or interfere with the Grantee's use, occupation or enjoyment of this easement.
