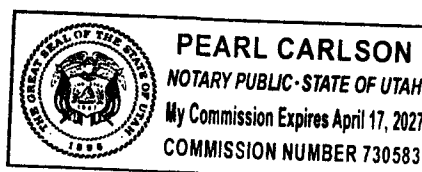


EXHIBIT A
Legal Description
