

THEREFORE, for valuable consideration received, Grantor conveys and releases to Grantee an undivided interest in and to the following described real property in Utah County, Utah:

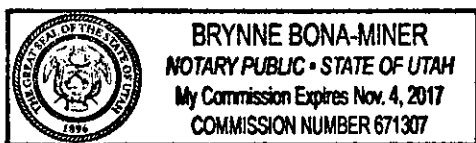


